TERMS & CONDITIONS OF SALE

ACCEPTANCE OF ORDERS

These Terms and Conditions are part of the HiSonic, LLC quotation and order acknowledgement, and together constitute a binding mutual agreement between the purchaser and HiSonic, LLC unless otherwise agreed in writing. All Terms shall be construed and governed by the laws of the State of Kansas.

QUOTATIONS

Price quotations are valid for ninety (90) days from the date of quotation unless otherwise agreed. All orders shall be at prices set forth in price quotations that are in effect at the time of placement of the purchase order. All prices are FOB shipping point unless agreed otherwise.

CANCELLATIONS

Orders shall only be cancelled subject to mutual consent and on terms which indemnify HiSonic, LLC against any loss.

TAXES

Prices are exclusive of any tax or other charges that Hisonic may be required to collect or pay upon the sale of items quoted. All purchase orders must note the existence and amount of any such charges that are the responsibility of Hisonic, LLC to collect, or indicate they are exempt by certificate.

PAYMENT

Net 30 days from the date of invoice. Terms are subject to credit approval at the time of acceptance of purchase order. Hisonic reserves the right to demand full or partial payment in advance if the financial condition of the buyer does not justify the terms of payment. Orders from new customers may be on a COD basis at Hisonic's discretion.

RISK OF LOSS

Risk of loss or damage shall pass to the Purchaser upon delivery of goods to the carrier at the F.O.B. shipping point. The responsibility for claims for in-transit damages and nonreceipt of goods is transferred to the buyer at the F.O.B. shipping point. Claims for damages should be made to the applicable carrier. Claims for shortages must be made to the carrier or to Hisonic, Inc not later than five (5) days after receipt of shipment.

TITLE

The right of possession of the items sold shall remain with Hisonic, LLC until all payments are made as agreed. No assignment of these items shall be made in any form until all payments are made.

RETURNS

Any item returned to Hisonic must have a Return Material Authorization (RMA) number. Contact Hisonic to obtain a RMA number.

WARRANTY

All items are warranted to be free from defects in material and workmanship for a period of one year from the date of manufacture, which is measured by the product date code. During the warranty period, parts determined to be defective by Hisonic shall be at Hisonic's discretion repaired or replaced free of charge. No warranty is implied with respect to damages arising from improper usage or handling.

PARTIAL VALIDITY

If any provision of these terms and conditions shall be held to be invalid, illegal or unenforceable such provision shall be enforced to fullest extent permitted by applicable law and the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.

NO WAIVER

Failure or delay of Hisonic, LLC to exercise a right or power under these terms and conditions shall not operate as a waiver thereof, nor any single or partial exercise of a right or power preclude any other future exercise thereof.
